1. The term of the Chairperson and members shall be for a period of two years.
2. The term of the Special Invitee shall be one year.
3. The quorum for the meeting including the chairperson, but excluding the special invitee, shall be three.
4. In considering the grievances before it, the SGRC shall follow principles of natural justice.
5. The SGRC shall send its report with recommendations, if any, to the Provost of Vanita Vishram Women's University and copy it to the aggrieved student, preferably within 15 working days from the date of receipt of the complaint.
6. Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of 15 days from the date of receipt of such decision.
7. Other terms and conditions *i.e.* the procedure for redressal of grievances by Ombudspersons and Students' Grievance Redressal Committee & Information regarding Ombudspersons and Students' Grievance Redressal Committees shall be as per UGC (Redressal of Grievances of Students) Regulation, 2023.
