General Rules and Regulations for the Students' Council Election 2024-25.

- The Election for the Students' Council Class Representatives and General Secretary for the year 2024-25 will be conducted on 06/09/2024.
- The age limit for the candidate contesting for the post of Students' Council Representative must not be more than 21 years at the Graduate level and 24 years at the Post-Graduate level. (as on 22/08/2024)
- If a student has failed in any year of the college, has got A.T.K.T in any semester or should not have any previous record of any serious offence; i.e. there should not be any ongoing inquire or any serious indiscipline/misbehaviour or case of using unfair practices during exam, then she will not be allowed to contest for the post of G.S. or Class Representative.
- The secretaries for the various committees will be selected from the elected candidates of the Class Representatives of the Students' Council.
- A student can present her candidature at the most once for the post of G.S and twice for the post of Class Representative during her entire studentship period.
- 60% attendance in class is a must for the candidate who gets elected.
- The nomination forms for the election will be available from 13/08/24 to 21/08/24 and will have to be submitted by the candidate herself only on 22/08/24 latest by 04:00 p.m. in Sports Office A Building.
- The filled Nomination forms can be withdrawn by 29/08/24 till 01:00 p.m. in Sports Office A Building.
- Canvassing for the election can be done in the classes on 02/09/24 and 03/09/24 till 05:25 p.m. with prior permission in written form and following the guidelines directed by the Registrar.
- As soon as the election procedure ends the counting of the votes will be done and the result will be declared immediately thereafter.
- In a class if the number of nomination forms received are same as the number of the posts decided for Class Representative, then the candidates will be elected automatically without contesting elections.
- Class Representative will be in proportion to the number of students in division (1 CR for class of 60 or less students) and (2 CR for more than 60 students).
- If in a class the number of nomination forms received are less than the number of posts decided for the Class Representative or if there are no nominations for the said post then selection procedure will be adopted by the Dean.
- Only the current year students studying in the college have the right to take part and vote in the elections. Students are instructed to bring their I-cards or the fee receipt of the 1st Term and Aadhar card without fail when coming to vote. Only those students who bring their I-cards or 1st Term fee receipt and Aadhar card will be allowed to cast their vote. Entry into the campus without I-card, Fees Receipt and Aadhar card is strictly prohibited.
- In case of any query regarding the Students' Council Election the candidate can contact any of the Election Committee Members as listed in Code of Conduct Form.

- The proposer and supporter of the candidate contesting in the Election for the post of the Class Representative should be from the same class and division as that of the candidate. Also the proposer and supporter should be different entities and must be from the class of the candidate.
- The candidate, the proposer and the supporter have to produce all the documents listed in the Application Form without fail.

The above election will be conducted according to the norms laid down by the University. The rules and regulation of the Students' Council as well as their instructions are subject to change as decided by the Election Committee.

In case of any discrepancy/issue regarding the rules and regulations pertaining to the students' Council Election, the decision of the Provost will be final and binding to all the students
